Introduction to Researcher Resilience Training (RRT) Program

The Researcher Resilience Training (RRT) program is an NIMH-funded program designed to provide advanced doctoral students and early career investigators of African descent interested in child and adolescent behavioral health, with the necessary research skills to address the significant challenges that exist within resource-poor settings. RRT fellows will receive didactic instruction, mentoring, "hands-on" immersion in child-focused studies, individualized consultation, goal setting, monitoring and ongoing support resources across time.





Riana Anderson, PhD

Assistant Professor, Health Behavior & Health Education, University of Michigan

Biography

Riana Anderson is interested in reducing racial stress and trauma and improving psychological well-being and family functioning among Black families. She uses mixed methods in clinical interventions to study racial discrimination and socialization in among Black families, focusing on how protective familial mechanisms such as parenting and racial socialization operate in the face of risks linked to poverty, discrimination, and residential environment. Dr. Anderson is particularly interested in how these factors predict familial functioning and subsequent child psychosocial outcomes, especially when enrolled in family-based interventions.
